## Disability Rights Advocates to Rally at Colorado State Capitol for D-RAD 2025 Event Highlights Critical Disability Legislation, Including HB 1017

[Denver, CO | March 5, 2025] Advocates, policymakers, and community leaders will gather this Thursday, March, 6t, at the Colorado State Capitol for Disability Rights Advocacy Day (D-RAD 2025)—an annual event dedicated to advancing disability rights. The event, running from 8 AM-12:15 PM, will highlight several policy initiatives, including House Bill 1017, a bipartisan initiative to protect individuals with disabilities from unnecessary institutionalization.

**Nancy Jensen**, a disability rights advocate and author of "The Girl Who Cried Wolf: A Memoir," is a particularly compelling voice on this issue. Having experienced unjust institutionalization firsthand, Jensen has testified before Congress about her fight for independence. She is available for interviews to share her story and discuss why **HB251017** is critical to ensuring that individuals with disabilities have the right to live independently in their communities.

"This bill is about ensuring that individuals with disabilities can live freely with dignity, rather than being forced into institutions," said Nancy Jensen. "As someone who had to fight for my own freedom, I know firsthand why this protection is so critical."

**HB25-1017** builds on the landmark Olmstead v. L.C. Supreme Court ruling by strengthening protections for people with disabilities. The bill requires public entities to administer services in the most integrated, appropriate setting and directs the state to develop a comprehensive community integration plan. The bill passed unanimously out of its first committee on February 17. Pending budget approval it moves to the House Appropriations Committee next.
